Nurses are the biggest group of health professionals within healthcare institutions. All nurses in clinical care document on patients' well-being and problems and the care they receive which leads to the creation of a huge amount of data in nursing. The nursing contribution to healthcare often remains hidden and clinical nursing data is undervalued. One reason for this may be that the documentation is not unified and standardized languages are not used in a consistent way worldwide. In nursing many different standardized nursing languages (SNL) are available and the American Nurses Association has for example identified 12 different terminologies.

In 2020 an agreement of collaboration between the International Council of Nurses (ICN) and SNOMED International was signed. After identification of equivalencies between SNOMED CT and the International Classification of Nursing Practice (ICNP) the 2019 version of ICNP was incorporated into SNOMED CT. With the addition of ICNP the specific nursing content in SNOMED CT has increased considerably, which benefits nursing everywhere, especially with the widespread use of SNOMED CT in electronic health records. ICNP represents nursing diagnoses, interventions, and outcomes and it is available as a separate product or a reference set. The next version of ICNP will be published in 2024. The collaboration opens the opportunity to increase access, distribution, and use of nursing terminology, via SNOMED CT locally, nationally, and globally.



ICN has recently published the report [Recover to Rebuild: Investing in the nursing workforce for health system effectiveness](#). **Our Nurses. Our Future** is the theme of the campaign for *International Nurses Day* on May 12 that will leverage a Charter of Change to value, protect, respect and invest in the world's nurses.

With the use of international terminology standard for nursing, such as ICNP in SNOMED CT, representation and comparison of nursing domain worldwide is facilitated and could be one of the actions to increase health system effectiveness. Adoption of such standards would ensure reliable and prompt capturing, storing and exchanging of nursing data and information across the health ecosystem, allowing high levels of interoperability at national and international levels.



The inaugural Nursing and Midwifery Digital Health Conference (#NMDHC23) will take place on **Saturday 8 July 2023** during #MedInfo23 in Sydney. The theme for the conference is 'Creating a Digitally Savvy Workforce.' A fascinating program has been developed, including a 90-minute session after lunch where participants will rotate through five stations to experience emerging technology. The conference offers a unique opportunity to network and learn from prominent international experts such as Professor Dawn Dowding from the UK, Toria Shaw Morawski from the US, Dr. Laura-Maria Peltonen from Finland, and local experts Dr Carey Mather, Liz Keen, Nicole Payne, Adjunct Prof Aaron Jones and Dr Nathan Moore.
